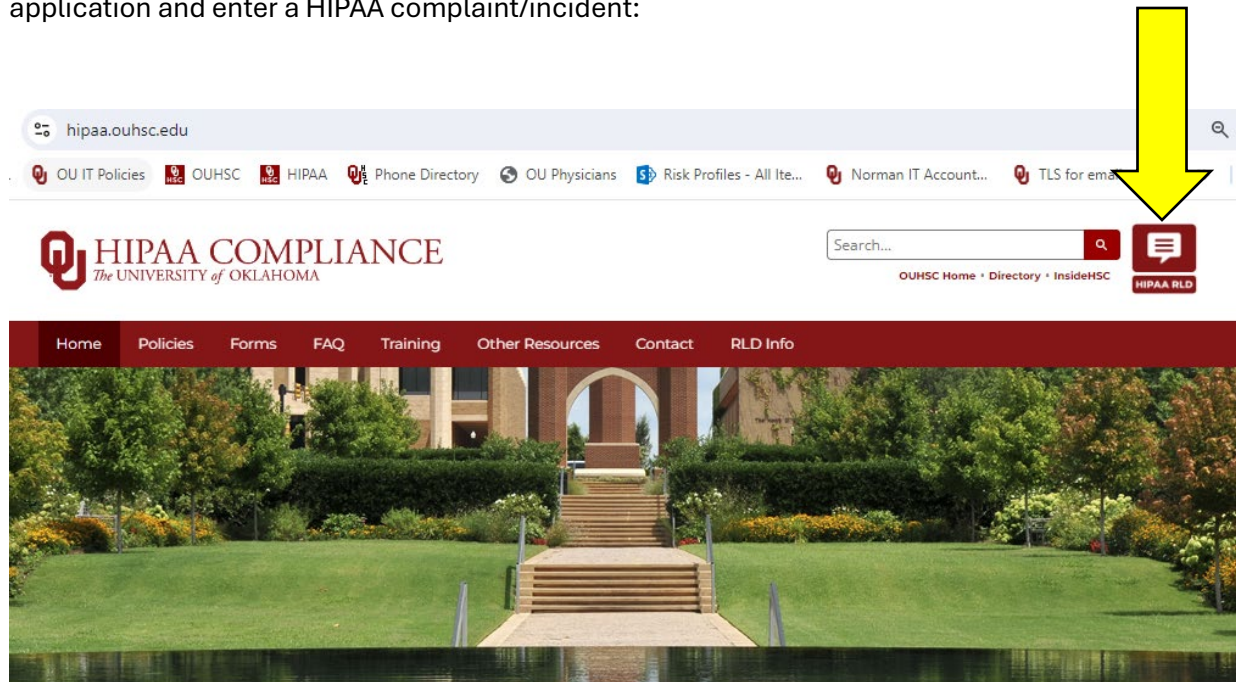

Fill out the form to report a violation of privacy rights protected by the Health Insurance Portability and Accountability Act (HIPAA).


